Release number.

Release-1 (Oct 2007) covered the 1968-1995 PSID family data.

Release-2 (Feb 2014) covers 1968-2009 PSID family data. This file carries forward the data/variables from release-1, and also adds 4 new variables: release number; revised assisted housing code, AHDCLREV (code frame is different from original variable used for 1968-1995); and two flag variables for using the two versions of the assisted housing code. Note that the 1995 data was recoded using the new code frame and up-to-date HUD records, which resulted in some 1995 records having different values than in release-1 (e.g. some records previously classified as receiving assistance are no longer classified, and vice versa).

Code crosswalk/recode between AHDCL920 and AHDCLREV (using SAS):
