This variable contains values for the PSID family interview number for each wave of CDS IPEDS data. IPEDSYEAR (Year of CDS Interview) must be used as a subset selector, since PSID family interview number values are not unique across waves. If the data are first subset using IPEDSYEAR, then the values here are unique within the selected wave and link the IPEDS data with the associated PSID wave's single year family-level data.

This variable contains values for the PSID Sequence Number of this individual on the Cross Year Individual File for each wave of IPEDS data. IPEDSYEAR (Year of Interview) and IPEDSYRID (PSID Family Interview Number) must be used as subset selectors, since family interview number values are not unique across waves. If the data are first subset using IPEDSYEAR and IPEDSYRID, then the values here are unique for each individual and may be used to link with the both the PSID Cross Year Individual File and the CDS Cumulative ID Map File for that person.
